## **Services of Funeral Director & Staff**

### **Basic Services of the Director and Staff.**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burials and forwarding and receiving of remains.

This includes:

- Basic overhead for providing mandated or other necessary facilities and licenses.
- Licensed Funeral Directors on call 24 hour a day.
- Service personnel available 24 hours a day to respond to all requests for assistance.
- Arrangement/Prearrangement conferences(s).
- Completion of all legally required papers.
- Securing all required legal permits.
- Retaining a permanent funeral record.

If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.)</i>

**DIRECT CREMATION** FROM \$850 to \$5284  
If you want to arrange a DIRECT CREMATION, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are Cardboard Alternative Container; Cremation Caskets: Any Wooden Casket.

ALL DIRECT CREMATION charges include: Basic Service of Director & Staff & Overhead, transfer of deceased to the funeral home, disinfection and transfer to crematory.
